



MCR MAT on-boarding

If you've any new establishments joining your Multi Academy Trust (MAT), they'll need to submit a Monthly Contributions Reconciliation (MCR) [On-boarding form](#). New establishments won't automatically join MCR, even if the MAT has already on-boarded.

They'll also need to submit a [Delegation form](#) to ensure the appropriate people have access to the [Employer Portal](#).
