

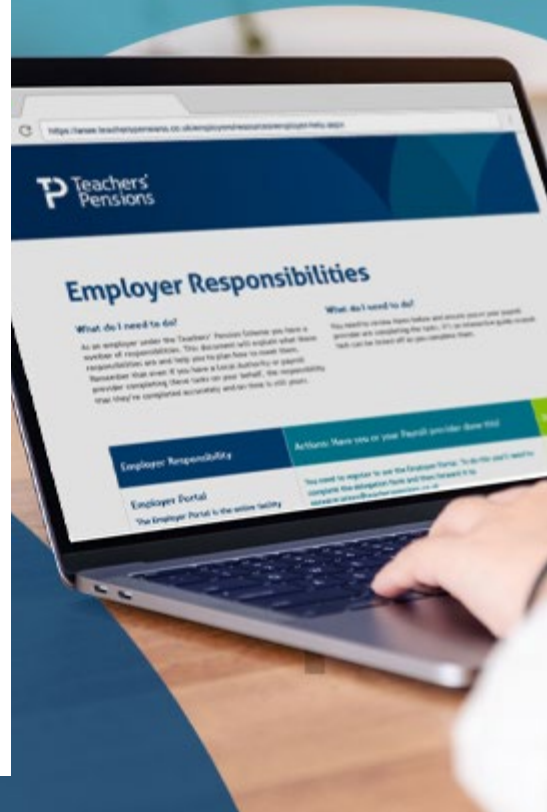
## Responsibilities document

We've recently updated our Employer Responsibilities Guide to help you understand what actions you're expected to do throughout 2021 along with the dates you need to do these by.

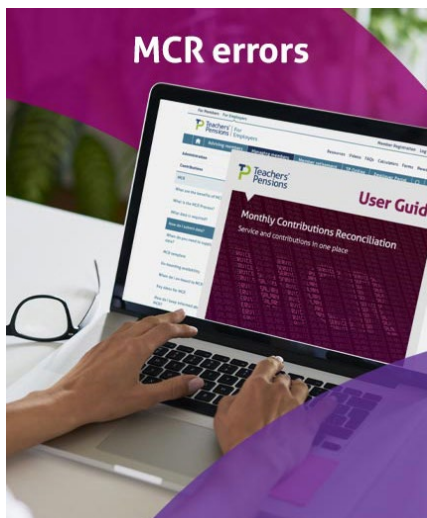

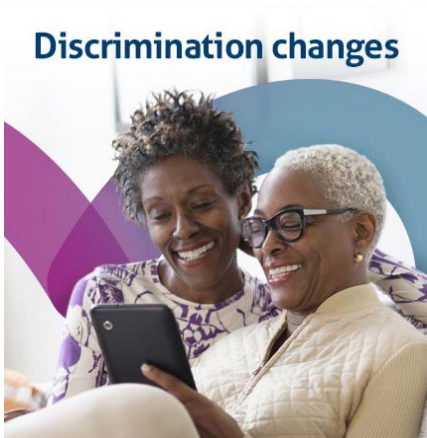


## Teachers' Pensions Action Forum (TPAF)

Following a recent legal challenge against the Teachers' Pension Scheme, the Department for Education (DfE) has agreed that there is evidence of sexual orientation discrimination within the Scheme rules for survivor benefits.
