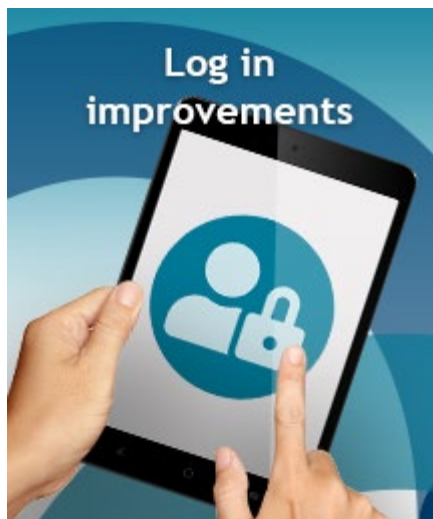
New guide to help with the End of Year Certificate (EOYC) process
