We always want to keep you informed of the latest changes here at Teachers' Pensions, and as we've recently made updates to our MCR web pages, we thought we'd let you know.

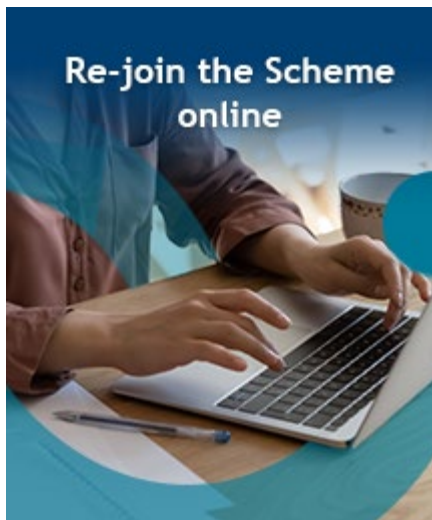
In addition to these changes, we've introduced three new bite sized videos to the website.

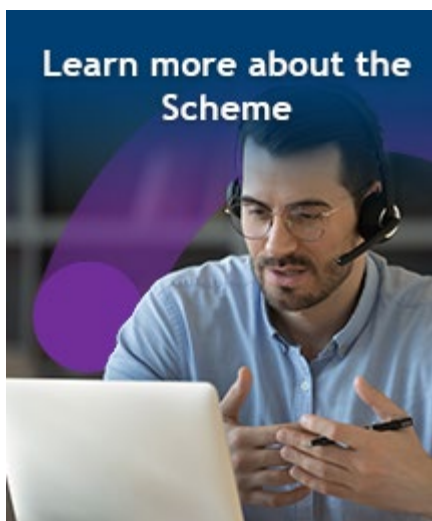


Opting in (Election to join) - now online
