


Transitional Protection rollback

On 1 October 2023, as part of the Transitional Protection remedy, any affected members will see their pensionable service accrued between 1 April 2015 and 31 March 2022 rolled back to the final salary scheme. Their Benefit Statement will be updated to reflect this.

This means members are treated as entering the career average scheme for the first time on 1 April 2022.

Due to changes introduced to the Teachers' Pension Scheme in relation to Transitional Protection, there may be members in your establishment who hold excess service, which can't be rolled back into the final salary scheme.




Teachers' Pensions Action Forum (TPAF)

Transitional Protection from 1 October
