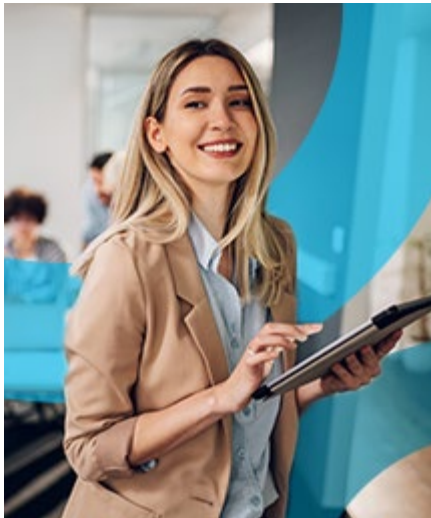
## Employer Secure Messaging
