



End of Year Certificate timetable

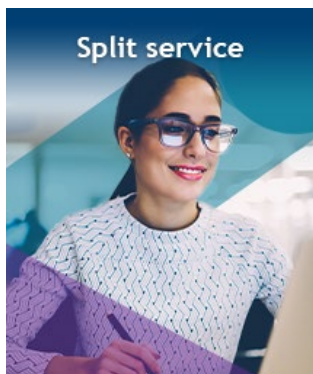
We'll soon be sending out an email to all establishments outlining some important dates for this year's EOYC process.

Split service

April submissions

It's nearly coming close to the end of the financial year and we're requesting that if any establishments have yet to submit any outstanding Monthly Breakdown forms that they're completed as soon as possible.

This is so that we can ensure all contributions are accounted for correctly. In April's submissions, all service needs to be split onto two lines, one from 1 - 5 April and the other covering 6 - 30 April.

Changes to the Scheme from 1 April 2022

As you may already be aware, the final salary (legacy) scheme is closing on 31 March 2022. This means that from 1 April 2022 all active members will build up their pension benefits in the career average (reformed) section of the Scheme.
