Your Benefit Statement is your check point

Your Benefit Statement is available for you to view via [My Pension Online](#) (MPO).

It's more important than ever to keep in touch with your pension and stay up to date with the Scheme. With your MPO account you can access your pension information wherever you are. So why not log in and stay in control of your savings?

We update your Benefit Statement monthly, so you can easily keep track of how your benefits are building up in the Scheme. Whilst it may not be the most important thing in your life right now, regular checks on your pension savings will make things easier in the future. If you're unsure about any of the information in your Statement or how to find it, check out our handy [guide](#) and short [video](#). If you think that any of the information in your Statement is inaccurate or there's missing service, we recommend that you contact the relevant employer.



Government Consultation for public sector pension schemes

The Government plans to publish a public consultation soon on changes to address the discrimination caused by transitional protection arrangements within the 2015 reforms to the main public sector pension schemes, including the Teachers' Pension Scheme. The usual consultation period is 12 weeks.

This will be your opportunity to provide feedback on the proposals, to address the discrimination identified in the McCloud Court of Appeal decision.

Remember the Government has confirmed that your pension entitlements are safe and that the changes it makes to remove the discrimination will be for all affected scheme members and not just those who have lodged claims.

Please make sure you check our website, or our social media pages for confirmation on the start date and a link to the consultation.

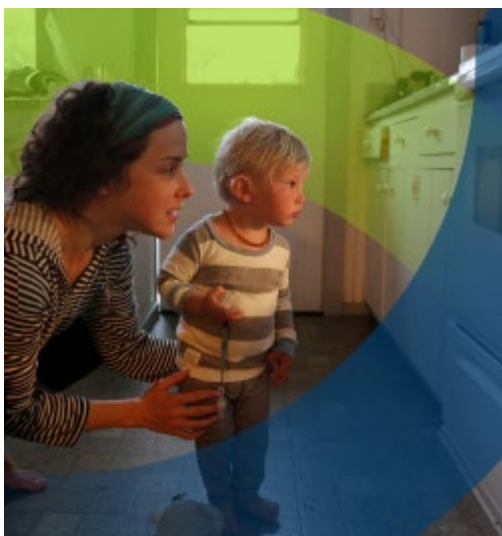


COVID-19 and your pension
