

### Take part in the government consultation

Back in July we let you know that the government was planning a consultation exercise to look at how to address the discrimination caused by the transitional protection arrangements, when the career average arrangement was introduced in 2015. ### Changes to survivor benefits

Following a recent claim brought against the Teachers' Pension Scheme (the Scheme), the Department for Education has accepted that there is direct sexual orientation discrimination within the Scheme rules, as the benefits payable to a

surviving male spouse or male civil partner of a female Scheme member may be less than would be payable if that member was in a same-sex marriage or same-sex civil partnership. This could affect beneficiaries of female members who had pensionable service prior to April 1988. You can find out more about this ruling and the actions being taken on our <u>website</u>.

We hope you find it simple to use, however if you need any help we've <u>FAQs</u> and a <u>video</u> to point you in the right direction.




#### Be scam aware

Your pension is likely to be your main source of income once you reach retirement, so it's important to do all you can to keep it safe from scammers. During COVID-19 there's been a significant increase in general scam activity. A cold call, email or text regarding your pension is illegal and is a scam warning sign.
