

Monthly Data Collection (MDC) errors

We've recently received several large file updates that span back several years. This has caused a high number of errors and has required manual intervention. Some of the problems have been due to providing previous years' service in a monthly format and covering service prior to the date the employer on-boarded onto MDC.

Please ensure when updating previous years' service, you do so in the correct format based on when you on-boarded onto MDC, as this will prevent errors from occurring.
