To date 17% of employers have not provided an Annual Service Return (ASR). That's over 204,588 members who have out of date service history and salary details. It's your responsibility to provide accurate information on your employees in a timely way to ensure the efficient running of the Scheme. We would therefore encourage you to submit your return if you haven't already done so.

Don't delay, on board to

Monthly Data Collection (MDC) today!

As previously advised MDC will be the only method of providing data to us from April 2018. The deadline for starting the on-boarding process is December 2017.

So far 1,057 employers have either made the switch or are in the process of moving to MDC, resulting in 124,000 members now benefiting from this new process.

Employers who are currently using MDC will, in most circumstances, no longer be required to complete a Certificate of Re-employment for members taking Age or Premature Retirement. This took effect from 7 July.

Be ready for Re-enrolment

On the third anniversary of your staging date you must assess each employee to determine whether they should be re-enrolled into the Scheme. For employees already in the Scheme you need to continue your existing processes, either through Annual Service Returns or Monthly Data Collection.

If an employee is not in the Scheme, you must assess whether they meet the criteria for re-enrolment. Our newly updated Auto-enrolment area can provide guidance on this.
