## Monthly Data Collection (MDC) Reminder Checklist

The new MDC Reminder Checklist, which helps you identify missing service in your MDC submission, will be going live from 14 September.

If you're missing any service details or withdrawal indicators in your submission, you'll be sent an email on the 14th of each month to let you know what you'll need to do next to correct this.

We'll run the report again on the 21st of the month and, if a checklist has not been returned, we'll notify you directly.

<p>There's recently been an increase in corrections made to previously submitted member service information.</p> <p>It's thought this is due to a rise in data cleanse exercises taking place. These exercises often identify changes that need to be made to historic data; however, any changes can impact important member events such as pension awards.</p>	<p>We've listened to your feedback and are pleased to announce that we're extending the session time for the Employer Portal from 20 to 30 minutes.</p> <p>This improvement should be implemented in late August/early September but we'll inform you when the change goes live through our <a href="#">website news</a>.</p>

### Reporting overtime

If you're reporting overtime on your MDC submission, the amount should be reported in the month it was earned and it should only be inputted in the overtime column of the MDC template.

If a member has more than one contract of employment at your school, the [concurrent calculator](#) must be used to calculate the service that needs to be recorded on the MDC submission.

### End of Year Certificate (EOYC) Processing

When submitting your EOYC figures please provide the contributions that should have been deducted and submitted, rather than the contributions that were actually paid.

### BACS Payments

When submitting a payment by BACS please use the same reference each time. The reference is used to automatically credit the payment to the correct employer as we match it to the employer record.

For this to work consistently, the reference on the file must match the reference in the employer record (exactly by characters) so it'd be extremely helpful if you can co-operate with us in this process.
