## Data processes are changing



**Monthly Data Collection (MDC)** removes the need for an Annual Service Return and has been introduced to make it simpler and quicker for you to provide member data. Its benefits include no longer needing to complete an Annual Service Return. **It's important to note that from April 2018 this will be the only method for providing data to us. The deadline for starting your on-boarding process is December 2017, but you don't have to wait until then, you can start using MDC now!**

The deadline for the Employer Review recommendations has been moved back to August 2016.

There's a lot of work taking place to look at how Monthly Data Collection (MDC) could be used to deliver contributions data collection. This could have implications for the future of the End of Year Certificate process once investigatory work has been completed and an end to end process has been mapped. Therefore additional time has been provided for this important process.

From 7 July 2016 there's a change for MDC users regarding the Certificate of Re-employment. In most cases you'll no longer need to complete any new Certificates of Re-employment for members taking Age or Premature Retirements. In some circumstances a certificate will be required and if this is the case we'll contact both you and the member.
