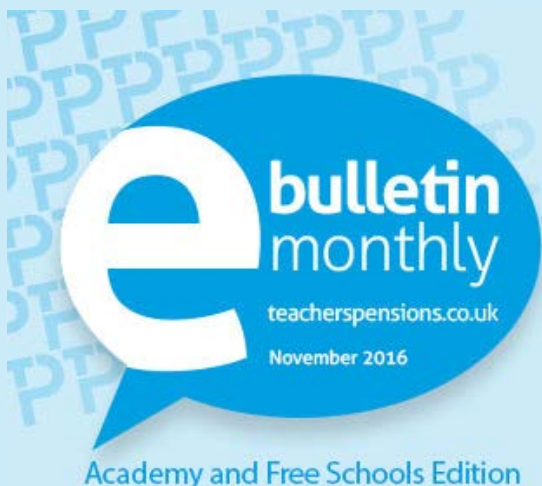

The new Employer Enrolment template was introduced on 14th November (formerly known as the Auto Enrolment template) and can be found on the [Employer Portal](#).

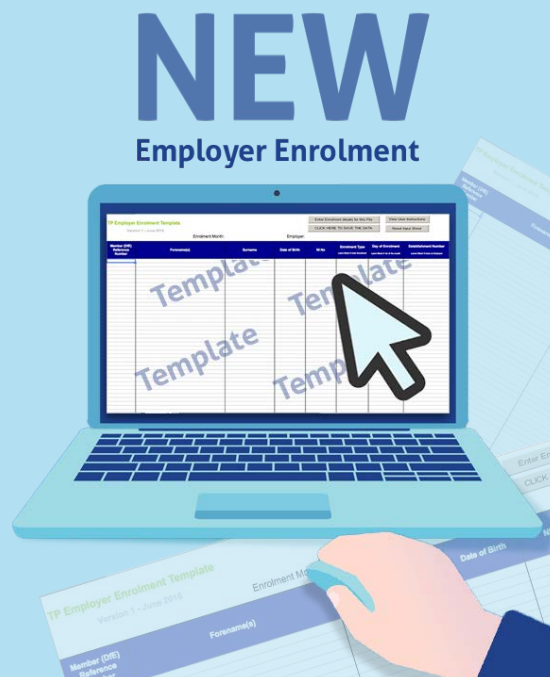
The template allows you to:

- specify if members have been contractually enrolled as well as auto enrolled,
- record all enrolment dates within the month (not just the 1st),
- record details for more than one establishment within one template.

There are instructions in the template for inputting data into the new fields.

Please ensure any outstanding [Annual Return](#) errors are corrected and returned to us as soon as possible.

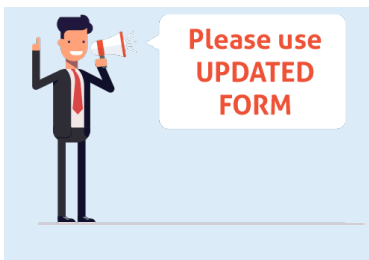

This year we've created resources for members to help them understand how to work through their Benefit Statement, which you may find useful too.

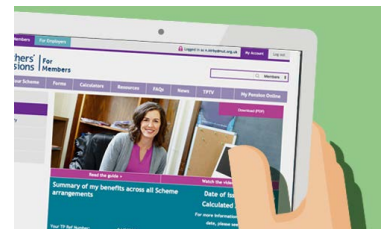

Employer Review

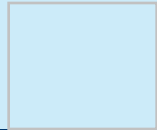
Work continues to progress on the Employer Review. The proposals were taken to the Teachers' Pension Scheme Pension Board in September and are now being amended in response to the feedback received.
