There's only one month left before the deadline to join on-boarding to MDC.

From April 2018, MDC will become the only way to submit service and salary details. Failure to join MDC will result in you failing to meet your statutory obligations as an employer and could result in escalation to The

Pensions Regulator.

If you, or your payroll provider, don't have an automatic solution in place to submit MDC data, we've a template available that'll enable you to send your monthly data to us. This [template](#) can also be downloaded from the [Employer Portal](#).

Therefore, we've changed the process and, in most cases, all that will be required is the member's surname, date of birth, National Insurance number and email address.

End of Year Certificate (EOYC)

If you've yet to submit an audited EOYC the deadline for all returns is 30 November. There will be no further extension to this deadline.

Contributions monthly breakdown form

Please remember that a monthly contribution breakdown form should be submitted at the same time you're paying contributions. This is to ensure that we can provide HM Treasury with the correct breakdown details of contributions received for you and members. If you've yet to submit any forms for current and prior months, please submit these as soon as possible. This information also assists the EOYC process at year end.

We still have a number of outstanding ASR submissions, with 188 employers having not provided a return. This means that 81,538 members could be affected. Therefore it's extremely important that this is returned to us as soon as possible.
