

Monthly Contributions Reconciliation (MCR) Error Reminder process

Correcting MCR warning errors is an essential task that we ask that you do. If you're not doing this on a regular basis, it may lead to incorrect contributions being deducted or leave us without some of the important information we require.

You may be suspended from submitting future MCR files if warning errors aren't corrected, so we've outlined further information on our website to assist you through the process.

Government revokes £95,000 cap on redundancy payments

It's been announced that the current cap on exit payments has been revoked.

The current cap, introduced in November 2020, is £95,000 and relates to Scheme members who are offered compensation alongside Premature Retirement or other exit-related payments.
